- (2) "Act" means the University Grants Commission Act, 1956 (U/S3 of 1956).
- (3) "Affiliated College" means a College recognised by, associated with and admitted to the privileges of a University.
- (4) "Board of Studies" means the Board of Studies of Streams of Constituent Units of Malla Reddy (MR) Deemed to be University.
- (5) "Campus" means Campus (single or multiple locations within the city) of Malla Reddy (MR) Deemed to be University wherein its facilities, faculty, staff, students, and Academic Departments are situated.
- (6) "Centre" means a Centre of Studies of Malla Reddy (MR) Deemed to be University.
- (7) "Chancellor", "Vice-Chancellor", and "Pro-Vice-Chancellor" means the Chancellor, Vice-Chancellor and Pro-Vice-Chancellor of Malla Reddy (MR) Deemed to be University, respectively.
- (8) "College" means any Institution whether Affiliated College or Constituent College, known as such or by any other name and provides Undergraduate, Postgraduate, Ph.D Programmes or all together, for obtaining any qualification from a University, in accordance with the rules and regulations of such University, which has been recognised as competent by the University Grants Commission to provide such programmes or courses of study.
- (9) "Commission" means the University Grants Commission (UGC) constituted under the Act.
- (10) "Constituent College" means a College operating under the administrative, academic, and financial control of the Malla Reddy (MR) Deemed to be University.
- (11) "Constituent Unit" means an Academic Unit (Colleges, Schools or Centres or Departments) of Malla Reddy (MR) Deemed to be University existing on the date of submission of a proposal to declare an institution to be Malla Reddy (MR) Deemed to be University.
- (12) "Department" means a Department of studies of Malla Reddy (MR) Deemed to be University.

- (13) "Distinct Category" means an existing institution or an institution starting from the beginning with the focus on teaching or research in the unique disciplines or addressing the strategic needs of the country or engaged in the preservation of Indian cultural heritage or preservation of the environment or dedicated to skill development or dedicated to sports or languages or any other discipline, as so determined by the Expert Committee approved by the Chairman of the Commission.
- (14) "Executive Council" means the Executive Council of Malla Reddy (MR) Deemed to be University.
- (15) "Expert Committee" means a Committee consisting of academics and other experts from other fields and includes representatives of the Statutory Bodies and approved by the Chairman of the Commission.
- (16) "Government" means the Department in the Ministry of Education in the Central Government dealing with the Higher Education.
- (17) "Institution" means an Institution of Higher Education engaged in teaching and research at the Undergraduate, Post-graduate or higher level.
- (18) "Institution Deemed to be University" means an Institution of Higher Education so declared by the Central Government by notification Under Section 3 of 1956 Act, on the advice of the Commission.
- (19) "Main campus" means the Campus of Malla Reddy (MR) Deemed to be University, where its major facilities, faculty, staff, students, academic departments and administration are situated.
- (20) MoA/Rules means Memorandum of Association and/or Rules of Malla Reddy (MR) Deemed to be University U/S 3 of the UGC Act, 1956).
- (21) "NAAC" means the National Assessment and Accreditation Council.
- (22) "NBA" means the National Board of Accreditation.
- (23) "Necessary Infrastructure" means the Infrastructure required under the norms of the concerned Statutory Body or the Commission, as the case may be.
- (24) "NEP" means the National Education Policy, 2020.
- (25) "NIRF" means the National Institutional Ranking Framework.
- (26) "Notification" means a Notification issued by the Central Government in the Official Gazette declaring Malla Reddy (MR) Deemed to be University Under Section 3 of the Act, 1956.
- (27) "Off-Campus" means the Premises of Malla Reddy (MR) Deemed to be University, approved by the Government, other than the Main Campus or the Campuses.
- (28) "Off-shore Campus" means the Premises of Malla Reddy (MR) Deemed to be University, approved by the Government, outside India, other than the Main Campus in India.
- (29) "Processing Fee" means the Fee to be paid by the applicant Institution to the Commission along with the application for processing such application.
- (30) "Regulations" means the University Grants Commission (Institutions Deemed to be Universities) Regulations, 2023.
- (31) "School" or "Faculty" means a School or Faculty of studies of Malla Reddy (MR) Deemed to be University.
- (32) "Sponsoring Body" means a body being a charitable or a not-for-profit society or trust or a company under Section 8 of the Companies Act, 2013 (18 of 2013), submitting an application for declaring an institution under its Administrative, Academic and Financial control as Malla Reddy (MR) Deemed to be University.

- (33) "Standing Committee" means a Committee consisting of academics and other experts from other fields and includes representatives of the Statutory Bodies and approved by the Chairman of the Commission.
- (34) "Statutory Body" means a body constituted under any law for the time being in force for determining or maintaining standards of quality in the relevant areas of higher education, including the All India Council for Technical Education (AICTE), the Bar Council of India (BCI), the Dental Council of India (DCI), the Indian Nursing Council (INC), the National Council for Teacher Education (NCTE) and the National Medical Commission (NMC), or any other Statutory Body established under an Act of Parliament.
- (35) "Teacher" means Professor, Associate Professor, Assistant Professor and such other academic staff as may be appointed for imparting instructions or conducting Research in Malla Reddy (MR) Deemed to be University including the Adjunct Faculty or Professor of Practice or Visiting Faculty.
- (36) The words and expressions used in these regulations and not defined, but defined in the Act will have the same meanings respectively assigned to them.

5. Objectives of Malla Reddy (MR) Deemed to be University

The objectives of Malla Reddy (MR) Deemed to be University will be -

- a) To provide for Higher Education leading to Excellence and Innovations in such branches of knowledge as may be deemed fit, primarily at Undergraduate, Post-graduate, and Research degree levels, fully conforming to the concept of a University.
- b) To engage in Inter-disciplinary or Multi-disciplinary or Trans-disciplinary Teaching and Research in addition to domain-specific specialisation.
- c) To provide for high-quality Teaching and Research recognised nationally and globally.
- d) To recognise, identify and foster the unique capabilities of each student, by sensitising teachers as well as parents to promote each student's holistic development.
- e) To provide multi-disciplinary and a holistic education in the faculties of science, engineering, technology, social sciences, arts, humanities, sports and other disciplines.
- f) To transform into Research and Teaching intensive University over a period of time.
- g) To focus on Research and Innovation by setting up start-up incubation centers; technology development centres; centres in frontier areas of research; greater industry-academic linkages & collaborations; and inter-disciplinary research including humanities and social sciences research.
- h) To provide flexible and innovative curriculum, which includes credit-based courses and projects in the areas of community engagement and service, environmental education, value-based education, etc.
- i) Contribute to social transformation through socially responsive teaching, learning, research, and fieldwork.
- j) To adopt the provisions of NEP, 2020; and
- k) To strengthen the research ecosystem by establishing Research and Development Cell (RDC).
- l) To possess such academic and physical infrastructure as may be specified by the Commission or the relevant statutory body, as the case may be.
- m) To have teacher-student ratio of 1:20 with a minimum combined faculty strength of not less than one hundred and fifty teachers and a minimum combined student strength of three thousand on rolls under the regular classroom mode, of which not less than one fifth being post-graduate or research or as per the norms of the relevant statutory body; and

- n) To have an administrative area, library, lecture halls, labs, hostels, health care, common facilities and recreational facilities.

6. Power and Functions of the Malla Reddy (MR) Deemed to be University

- 6.01 To carry out its objectives and for the management and properties of the Deemed to be University, it shall have the following powers.
- 6.02 To establish courses of study and research and to provide instruction in such branches of study as the Institute deems appropriate for the advancement of learning and dissemination of knowledge in such branches.
- 6.03 To conduct innovative experiments in new methods and technologies in the field of technical education in order to maintain international standards of such education, training and research.
- 6.04 To develop and maintain relationship with centers of excellence in Medical, Dental, Nursing, Pharmacy & Engineering in India and abroad for education, training and research including distance learning programs with the prior approval of UGC.
- 6.05 To prescribe courses and curricula for various courses of studies and provide for flexibility in the education system.
- 6.06 To conduct examinations and grant such degrees, diplomas or other academic distinctions as may be laid down in the regulations, subject to recognition by any statutory body under any law, if required.
- 6.07 To confer degrees and to grant Diplomas and/or Certificates to persons who have satisfactorily completed the approved courses of study and/or research as may be prescribed and shall have passed the prescribed examinations.
- 6.08 To provide for high quality teaching and research and for the advancement of knowledge and its dissemination through various research programme, Fellowships undertaken in-house by substantial number of full-time faculty / research scholars (Ph.Ds. and Post Doctoral) in diverse disciplines.
- 6.09 To co-operate with other national and international institutions in the conduct of research and higher education with prior approval of UGC.
- 6.10 To take decisions on questions of policy relating to the administration of the affairs and working of the MRV.
- 6.11 To take decisions regarding the admission of students for the courses offered by the MRV.
- 6.12 To award visitor ship, fellowship, exhibits, prizes and medals.
- 6.13 To provide for instruction, teaching and training in such branches of learning and courses of study as MRV may, from time to time, determine.
- 6.14 To make provision to enable constituent colleges to undertake specialized studies.
- 6.15 To organize and manage departments, laboratories, libraries, museums and equipment for the purpose of teaching, learning and research.
- 6.16 To establish, maintain and manage institutions of research, and specialized study centers.
- 6.17 To establish, maintain and manage constituent colleges, Schools, institutions, hostels, health centers, auditoria and gymnasia.
- 6.18 To provide for establishment of off-campus and off-shore campuses for serving a group of constituent colleges, and also to provide for and maintain common resource centers in such campuses in the form of libraries, laboratories, equipment, computer centers, hostels and such facilities for campuses to create centers of excellence as per UGC Regulations.

- 6.19 To create posts of Principals, Professors, Associate Professors, Readers, Assistant Professors, Lecturers and other teaching or non-vacation academic posts required by MRV with the prior approval of the sponsoring Body and to prescribe their qualifications and make appointments thereto.
- 6.20 To appoint or recognize persons working in any other university, industry or organization as adjunct Professors, adjunct Associate professors, adjunct Readers, adjunct Assistant professors, adjunct Lecturers and visiting Professors of MRV
- 6.21 To create non-teaching, skilled, administrative, ministerial and other posts and prescribe their qualifications, pay- scales and service rules with prior approval of the sponsoring Body and to make appointments there to.
- 6.22 To hold examinations and confer degrees and post-graduate, diplomas, and award post- higher secondary diplomas, fellowship and certificates and other academic distinctions on persons who
 - a) Unless exempted there from in the manner prescribed, have pursued approved courses of study in MRV and have passed the examinations prescribed by MRV.
 - b) Have pursued approved courses of study in MRV and have passed the examinations prescribed by MRV; or
 - c) Have engaged in research under conditions provided by Bye-Laws.
- 6.23 To confer Honorary Degrees or other academic distinctions as prescribed by the Bye-Laws.
- 6.24 To evaluate and assess the academic performance of constituent colleges and their periodical accreditation with the help of accreditation agencies like NBA, NIRF, NAAC, ISO and NABH etc.
- 6.25 To hold and to manage Trusts and Endowments and Institute and Award Fellowships, Travelling Fellowships, Scholarships, Studentships, Medals and Prizes for teachers and students of MRV.
- 6.26 To fix, demand and receive or recover such fees and other charges as may be regulated by the Bye-Laws from time to time and fee regulations.
- 6.27 To supervise, control and regulate the conduct and discipline of the students of MRV and hostels.
- 6.28 To provide for mobility of students from formal to non-formal stream and vice-versa.
- 6.29 To make arrangements for promoting welfare of the employees of MRV.
- 6.30 To co-ordinate and regulate teaching and research in the constituent colleges.
- 6.31 To provide for the training and quality improvement of teachers and non- teaching employees.
- 6.32 To provide for periodical assessment of the performance of teachers and non-teaching employees of MRV in accordance with the provisions of the Bye-Laws.
- 6.33 To regulate and provide for attendance of the teachers on the premises of MRV during teaching hours and beyond teaching hours, as prescribed and to prohibit teachers from taking or conducting private tuition or private coaching classes.
- 6.34 To provide for conduct and discipline rules for teaching and non-teaching staff and the enforcement thereof.
- 6.35 To maintain records, documents and returns of MRV.

- 6.36 To establish, maintain and manage, whenever necessary
- a) Printing and Publication Department;
 - b) Extension Boards of MRV;
 - c) Information Bureau;
 - d) Employment Guidance Bureau; and
 - e) Such other activities as may be necessary and possible to fulfil the objects of the MRV;
- 6.37 To make provision for participation of students in —
- a) The National Service Scheme;
 - b) The National Cadet Corps;
 - c) Home Guards and Civil Defence;
 - d) The National Sports Organizations
 - e) Youth Red Cross;
 - f) Extra-Mural Teaching Learning and Research;
 - g) Centre for Distance Education;
 - h) Programmes related to adults and continuing education, and extension;
 - i) Any other programmes, services or activities directed towards cultural, economic and social betterment as may be necessary and possible to fulfil the objectives of the MRV.
- 6.38 To provide for special training or coaching for competitive examinations, for recruitment to the public services, public undertakings and other competitive employment opportunities.
- 6.39 To co-operate or collaborate with any other University, Institution, Authority or Organization within and outside India for research and advisory services and for such purposes to enter into appropriate arrangement with other Universities, Institutions, Authorities, or Organizations to conduct certain courses as the situation may demand;
- 6.40 To organize training programmes for the faculty and supporting staff.
- 6.41 To borrow funds for the purposes of the MRV on the security of the property of the University, with the prior permission of the sponsoring body.
- 6.42 To explore the possibilities of augmenting the resources of the MRV by exploring or innovating activities such as research and development, consultancy, training programmes and providing services for different clients from industry, trade or any other non-government organizations;
- 6.43 To undertake academic collaboration and twinning programmes with universities and institutions abroad, with the approval of the Central Government wherever necessary.
- 6.44 To receive funds for collaboration programmes from foreign agencies, subject to rules and regulations of the Central Government wherever necessary.
- 6.45 To lay down service conditions for teachers including code of conduct, workload, norms of performance appraisal, and such other instructions or directions as, in the opinion of the university, as maybe necessary in academic matters.
- 6.46 To undertake development programmes in higher education, research, consultancy-based projects and training programmes for outside agencies, by charging fees, so as to generate resources.
- 6.47 To make special provisions for benefit of the MRV, education to be made available to classes and communities which are socially and educationally backward.

- 6.48 To make special provision for such benefits of the MRV, education to be made available for women students and handicapped students as the MRV may think necessary.
- 6.49 To make special provision for higher education in rural and tribal areas.
- 6.50 To implement the national literacy and adult education programme through teachers and students on voluntary basis in the MRV system and to evolve measures to give due weightage to the efforts and performance of the students in this area in addition to their normal academic performance, and to evaluate the performance of the teachers in this area.
- 6.51 To develop linkages with the industry for fulfillment of the objectives of the Institute.
- 6.52 To accredit the relevant courses of other centers/institutions of the corporate sector and others.
- 6.53 To develop and maintain twinning arrangements with other Institutes/ Universities/ Organizations / Centers of excellence in India and abroad for education, training and research in accordance with UGC Guidelines.
- 6.54 To admit any other center/institution established and run by the Malla Reddy (MR) the Sponsoring Society of this Academy, anywhere in India and abroad as a constituent body of the Institute for the purpose of its academic program and admitting it for the award of Degrees, Diplomas, Fellowship and Certificates of the Academy on fulfillment of the prescribed requirements by the recipients.
- 6.55 To establish any other Institute Campus anywhere in India and abroad in accordance with UGC Guidelines.
- 6.56 To deal with property belonging to or vested in the MRV in any manner which is considered necessary for promoting the objects of the Institute.
- 6.57 To do such other acts and things as may be necessary for the furtherance of the objects of the MRV.
- 6.58 No new department within the Campus, Off-Campus Centers/ Institutions / Offshore Campus shall be started without approval of Academic Council of the MRV with due intimation to UGC.
- 6.59 Programmes under Distance Education Mode shall not be started without approval of DEC and UGC.
- 6.60 All moveable and immoveable assets of the MRV shall be used only for the purpose of conducting academic activities, promotion of research and related administrative requirements of the Institution Deemed to be University.
- 6.61 To perform such other functions as deemed fit by the MRV.

7. Corpus Fund

- (1) A Corpus Fund of rupees Twenty-Five Crores or as decided by the Commission from time to time, will be created and maintained in the name of Malla Reddy (MR) Deemed to be University.
- (2) The interest accrued on the corpus fund will be used only for the purpose of further development of Malla Reddy (MR) Deemed to be University; and
- (3) Malla Reddy (MR) Deemed to be University may invest the corpus fund in any suitable scheme or schemes.

8. Off-Campus Centers and Off-Shore Campuses

Off-Campus centers and Off-Shore campus center shall be started by the Deemed to be University only in accordance with the UGC Regulations.

(A) Off-campus centres:

- (1) (i) Malla Reddy (MR) Deemed to be University with minimum 'A' grade and above or ranked from 1 to 100 in the "Universities" category of NIRF Rankings are eligible to set up off-campus centres.
(ii) Institution declared as Deemed to be a Universities declared under "Distinct Category" may apply for off campuses after five years of their declaration, if they fulfill the criteria specified in clause (i).
- (2) Malla Reddy (MR) Deemed to be University will have the infrastructure at the proposed off-campus centres in accordance with the norms and standards specified by the relevant Statutory Body or the Commission, as the case may be, and Malla Reddy (MR) Deemed to be University will start the off-campus centre with a minimum of five Undergraduate or Postgraduate or Research or Combination thereof with a minimum of one thousand students, of which not less than one-fifth of the students will be Postgraduate or Research Students with fifty teachers and with required infrastructure facilities.
- (3) The Government may withdraw the approval granted for starting the off-campus centre if at any time, it is found that the information provided by Malla Reddy (MR) Deemed to be University is incorrect and in order to protect the interests of students enrolled at such centre, Malla Reddy (MR) Deemed to be University will take necessary action for shifting of such students to the main campus.
- (4) Malla Reddy (MR) Deemed to be University will start new courses or programmes in any field in their existing campus and approved off-campus centres only with the prior approval of its Executive Council and also, wherever applicable, with the approval of the relevant statutory bodies:

(B) Off-shore campus:


- (1) Malla Reddy (MR) Deemed to be University may start or establish off-shore campuses with the prior approval of the Central Government in accordance with the provisions of the Act, rules and regulations made there under.
- (2) Existing off-shore campuses will continue to operate, provided they have obtained proper permissions and approval.

9. Monitoring the performance of the Deemed to be University

- (1) The Commission will monitor the performance and academic outcomes of Malla Reddy (MR) Deemed to be University.
- (2) The Commission will decide on the physical verification of Malla Reddy (MR) Deemed to be University or constitute teams for such verification on its own or upon receipt of any complaint against the accuracy and veracity of the information submitted to the Commission and also hosted on the website of Malla Reddy (MR) Deemed to be University.

10. Governance:

- (1) Malla Reddy (MR) Deemed to be University will be registered as a not-for profit society under the Societies Registration Act, 1860 (21 of 1860) or as a not-for-profit company registered under section 8 of the Companies Act, 2013 (18 of 2013):

PROVIDED that a sponsoring body exclusively established for running educational institutions will be exempted from registering as a separate not-for-profit society or trust or a company and the sponsoring body will specifically mention in its registration deed that the sponsoring body is exclusively for running educational activities and no other activities are being carried out or will be carried out in the future under it:

PROVIDED also that the sponsoring body will make available the necessary infrastructure for operating Malla Reddy (MR) Deemed to be University without any rental or other such charges.

- (2) All moveable and immovable assets of Malla Reddy (MR) Deemed to be University will be used for the purposes of conducting academic activities, promotion of research and related administrative requirements of Malla Reddy (MR) Deemed to be University, including the outreach educational activities.
- (3) The highest governing body of Malla Reddy (MR) Deemed to be University will be the Executive Council to be headed by the Vice-Chancellor and consisting of not less than ten and not more than thirteen members.
- (4) The Executive Council will be the principal executive body of Malla Reddy (MR) Deemed to be University.

11. The Composition of the Executive Council will be as under


- a) Vice-Chancellor - Chairperson;
- b) Pro-Vice-Chancellor (wherever applicable);
- c) Two members from amongst the Deans of schools of studies, by rotation, to be appointed by the Vice-Chancellor;
- d) One Professor, who is not a Dean, by rotation, to be appointed by the Vice-Chancellor;
- e) One Associate Professor, by rotation, to be appointed by the Vice-Chancellor;
- f) One Assistant Professor, by rotation, to be appointed by the Vice-Chancellor;
- g) One representative will be nominated by the Commission;
- h) Up to four nominees of the Sponsoring body; and
- i) The Registrar, who will be the ex-officio Secretary of the Executive Council.

12. Tenure of the members of Executive Council

- (1) All the members of the Executive Council, other than the Vice-Chancellor and Pro-Vice-Chancellor, will hold office for a term of three years, and in the case of Deans, the term will be three years or until they hold the office of Dean, whichever is earlier.
- (2) Members of the Executive Council appointed by the Vice-Chancellor from Professor, Associate Professor, and Assistant Professor categories will hold office for a period of one year or till such time they cease to be teachers of Malla Reddy (MR) Deemed to be University, whichever is earlier.

13. Powers and Limitations of Executive Council

- (1) The Executive Council will have the power of management and administration of Malla Reddy (MR) Deemed to be University.

- (2) The Executive Council will be the final decision-making body of Malla Reddy (MR) Deemed to be University in respect of every matter of Malla Reddy (MR) Deemed to be University, including academic, administrative, personnel, financial, and developmental matters.
- (3) Subject to the provisions of these regulations and the rules of Malla Reddy (MR) Deemed to be University, the Executive Council will, in addition to all other powers vested in it, have the following powers:—
- i. To appoint such Professors, Associate Professors, Assistant Professors, and other academic staff, including Chairs, as may be necessary, on the recommendation of the Selection Committee constituted for the said purpose and to fill up temporary vacancies therein;
 - ii. To regulate and enforce discipline amongst the employees of Malla Reddy (MR) Deemed to be University in accordance with the rules of Malla Reddy (MR) Deemed to be University;
 - iii. To provide for the appointment of Visiting Professors, Emeritus Professors, Professor of Practice, Consultants, Scholars, etc., and determine the terms and conditions of such appointments;
 - iv. To exercise such other powers and perform such other duties as may be conferred or imposed on it by the rules and regulations of Malla Reddy (MR) Deemed to be University;
 - v. To make rules and regulations for Malla Reddy (MR) Deemed to be University;
 - vi. The Executive Council shall not infringe upon the powers of the respective authorities provided under these Regulations; and where any authority has been given advisory /recommendatory powers, the Executive Council shall obtain advice/recommendations from such authority, before deciding on any matter before it.
 - vii. To establish, on the advice of the Academic Council, Divisions and Departments for the academic work and functions of the institution deemed to be University and to allocate areas of study, teaching and research to them.
 - viii. To create teaching and academic posts, to determine the number, cadres and qualifications thereof as approved by the Commission, and statutory body concerned and the emoluments of such posts in consultation with the Finance Committee.
 - ix. To create administrative, ministerial and other necessary posts in terms of the cadres laid down and to make appointment thereof in consultation with the Finance Committee.
 - x. To entertain and adjudicate upon and, if thought fit, to redress any grievances of the employees and students of the institution deemed to be university.
 - xi. To grant leave of absence to the Vice-Chancellor and to make necessary arrangements for carrying on his/her functions during the period of absence.
 - xii. To approve the award of Degrees and Diplomas based on the results of examinations and tests and to confer, grant or award Degrees, Diplomas, Certificates and other academic titles and distinctions.

- xiii. To fix the emoluments and travelling and other allowances of examiners, moderators, tabulators and such other personnel appointed for examinations in consultation with the Academic Council and the Finance Committee.
- xiv. To institute Fellowships, including Travel Fellowships, Scholarships, Studentships, Medals and Prizes in accordance with the Rules to be framed for the purpose.
- xv. To purchase, take on lease or accept as gift or otherwise any land or buildings or works which may be necessary or convenient for the purpose of the institution deemed to be university, on such terms and conditions as it may deem fit and proper, and to construct or alter and maintain any such building(s) or work(s).
- xvi. To transfer or accept transfers of any movable property on behalf of the institution deemed to be university.
Provided that the Executive Council shall not transfer or alter ownership in any manner whatsoever of any movable or immovable property of the institution deemed to be university without the approval of the sponsoring Society/Trust/Company.
- xvii. To execute in consultation with the Society/Trust/Company (if any) conveyance, transfer Government Securities, re-conveyances, mortgages, leases, bonds, licenses and agreements in respect of property, movable or immovable, belonging to the institution deemed to be university or to be acquired for the purposes of the institution deemed to be university.
- xviii. To issue appeals for funds for carrying out the objectives of the institution deemed to be university and, consistent with the provisions of the objectives, to receive grants, donations, contributions, gifts, prizes, scholarship, fees and other moneys, to give grants and donations, to award prizes, scholarships, etc.
- xix. To raise and borrow in consultation with the Society/Trust/Company (if any) money on bonds, mortgages, promissory notes or other obligations or securities founded or based on any of the properties and assets of the institution deemed to be university, or without any securities, upon such terms and conditions as it may think fit and to pay out of the funds of the institution deemed to be university, all expenses incidental to the raising of money and to repay and redeem the money borrowed.
- xx. To maintain a fund to which shall be credited:
(a) all moneys provided by the Central or State/University Grants Commission;
(b) All fees and other charges received by the institution deemed to be university;
(c) all money received by the institution deemed to be university as grants, gifts, donations, benefactions, bequest or transfers and
(d) all money received by the institution deemed to be university in any other manner or from any other source;
- xxi. To open account or accounts of the institution deemed to be university with anyone or more scheduled banks and to lay down the procedure for operating the same.

- xxii. To deposit all moneys credited to the funds in scheduled banks or to invest them in consultation with the Finance Committee.
- xxiii. To invest the funds of the institution deemed to be university or money entrusted to the institution deemed to be university in or upon such securities and in such manner as it may deem fit and from time to time transpose any investment.
- xxiv. To maintain proper accounts and other relevant records and prepare Annual Statements of Accounts, including the balance sheet for every previous financial year, in such form as may be prescribed by the Regulations/Bye-Laws.
- xxv. To manage, regulate and administer the revenue, the finance, accounts, investments, properties, business and all other administrative affairs of the institution deemed to be university and for that purpose to appoint such agent or agents as it may deem fit.
- xxvi. To provide building or buildings, premises, furniture, fittings, equipment's, appliances and other facilities required for carrying on the work of the institution deemed to be university.
- xxvii. To establish, maintain and manage residencies for faculty and staff and hostels for the students of the institution deemed to be university.
- xxviii. To recognize and maintain control and supervision on hostels owned and managed by other agencies for the students of the institution deemed to be university and to rescind such recognition.
- xxix. To appoint such committees for such purpose and with such powers as the Board of Management may think fit and to co-opt such persons on these Committees as it thinks fit.
- xxx. To appoint in order to execute an instrument or transact any business of the institution deemed to be university, any person as attorney of the institution deemed to be university with such powers as it may deem fit.
- xxxi. To appoint Auditor(s) for the ensuing year.
- xxxii. To select an emblem and to have a common seal for the institution deemed to be university and to provide for the custody and use of such seal.
- xxxiii. To delegate all or any of its powers to any Committee or sub-Committee constituted by it or the Vice-Chancellor of the institution deemed to be university or any other person.
- xxxiv. To conduct all administrative affairs of the institution deemed to be university not otherwise specifically provided for;
- xxxv. To take all necessary decisions for the smooth and efficient functioning of the institution deemed to be university.
- xxxvi. To exercise such other powers and perform such other duties as may be conferred or imposed on it by the rules and regulations of the institution deemed to be University.

14. Meetings of Executive Council

- (1) The Executive Council will meet at least four times a year (minimum two in one semester), with not less than seven days' prior notice given before every meeting of the Executive Council, and emergency meetings may be convened at a shorter notice, for reasons to be recorded in writing for such emergency meeting.
- (2) One-third of the total number of members of the Executive Council will form the quorum for the meeting.
- (3) In the absence of the Vice-Chancellor, the Pro-Vice-Chancellor will preside over the meeting; and where there is no Pro-Vice-Chancellor in Malla Reddy (MR) Deemed to be University, a member chosen by the other members of the Executive Council present at the meeting will preside over the meeting.
- (4) Every member of the Executive Council, including the Chairperson, will have one vote and the decisions at the meetings of the Executive Council will be taken by simple majority; and in case of a tie, the Chairperson will have a casting vote.
- (5) Any business which may be urgent in nature may be carried out by circulation amongst its members.
- (6) A copy of the minutes of each meeting will be furnished to the Chancellor of Malla Reddy (MR) Deemed to be University, as soon as possible after the convening of the meeting.

15. Termination of membership

If a member, other than the Vice-Chancellor and those representing the teachers, accepts a full-time appointment in Malla Reddy (MR) Deemed to be University, or fails to attend three consecutive meetings of the Executive Council without proper leave of absence, such member will cease to be a member of the Executive Council.


16. Delegation of powers of Executive Council

The Executive Council may, by a resolution, delegate to the Vice-Chancellor or any other officer or faculty or to a Committee of officers or faculties of Malla Reddy (MR) Deemed to be University, such powers as it may deem fit, subject to the condition that the action taken by the Vice-Chancellor or the officer or faculty or the Committee in the exercise of the powers so delegated will be reported at the next meeting of the Executive Council.

17. Other authorities of Malla Reddy (MR) Deemed to be University

A. Academic Council:

- (1) The Academic Council will be the principal academic body of Malla Reddy (MR) Deemed to be University and will, subject to the provision of the rules of Malla Reddy (MR) Deemed to be University, co-ordinate and exercise general supervision over the academic policy of Malla Reddy (MR) Deemed to be University.
- (2) The composition of the Academic Council will be as under—
 - i. Vice-Chancellor - Chairperson;
 - ii. Pro Vice-Chancellor (wherever applicable);
 - iii. Deans of faculties of the schools and heads of the departments or centres;

- iv. Up to ten Professors (excluding those who are Deans of schools and heads of departments or centres) by rotation, to be nominated by the Vice-Chancellor giving due regard to the representation of different schools or departments or centres;
 - v. Up to five Associate Professors from departments or centres other than the heads of the departments or centres, by rotation, to be appointed by the Vice-Chancellor;
 - vi. Up to five Assistant Professors from the departments or centres other than the heads of the departments or centres, by rotation, to be appointed by the Vice-Chancellor;
 - vii. Six persons of repute from amongst the educationists or experts for their specialised knowledge, who are not in the service of Malla Reddy (MR) Deemed to be University, nominated by the Vice-Chancellor; and the Registrar, who will be the ex-officio Secretary of the Academic Council.
 - viii. The Registrar, who shall be the ex-officio Secretary of the Academic Council.
- (3) The representation of different categories will be through rotation and not through an election, and the term of members, other than the ex-officio members, will be three years; and the Controller of Examination will be the permanent invitee to the meetings of the Academic Council.

B. Powers and Functions of Academic Council:

Subject to the provisions of these regulations and rules of Malla Reddy (MR) Deemed to be University, the Academic Council will, in addition to all other powers vested in it, have the following powers, namely: —

- (1) To exercise general supervision over the academic policies of Malla Reddy (MR) Deemed to be University and to give directions regarding methods of instruction, co-ordination of teaching among departments or faculties or schools or centers, evaluation of research and improvement of academic standards;
- (2) To bring about and promote inter-departmental, inter-faculty, inter-school, inter-center co-ordination and to establish or appoint such committees or boards, as may be deemed necessary for the purpose.
- (3) To consider matters of general academic interest either on its own initiative or on a reference by a department or faculty or school or center or the Executive Council, and to take appropriate action thereon;
- (4) To prescribe courses or programmes of study leading to degrees and diplomas of Malla Reddy (MR) Deemed to be University;
- (5) To make arrangements for the conduct of examinations in conformity with the rules and bye-laws of Malla Reddy (MR) Deemed to be University;
- (6) To maintain proper standards of the examination;
- (7) To recognise diplomas and degrees of Universities and other Institutions and to determine equivalence with the diplomas and degrees of Malla Reddy (MR) Deemed to be University;
- (8) To institute Fellowships, Scholarships, Medals, Prizes, etc.;

- (9) To frame rules covering the academic functioning of Malla Reddy (MR) Deemed to be University, admissions, examinations, award of fellowships and studentships, free-ships, concessions, attendance, discipline, residence, etc.;
- (10) To take a periodical review of the activities of the departments or centres and to take appropriate action to maintain and improve the standards of instruction;
- (11) To recommend the institution of teaching posts (Professors, Associate Professors, and Assistant Professors) to the Executive Council;
- (12) To make recommendations to the Executive Council for the establishment or abolition of departments or centres or schools or faculties, etc.;
- (13) To make recommendations to the Executive Council; and
- (14) To exercise such other powers and to perform such other duties, as may be conferred or imposed upon it by the rules of Malla Reddy (MR) Deemed to be University.

C. Meeting of Academic Council

- (1) The Academic Council will meet as often as necessary but not less than four times (at least two times in a semester) during an academic year with not less than seven days prior notice being given before every meeting of the Academic Council, and emergency meetings may be convened at a shorter notice, for reasons to be recorded in writing for such emergency meeting.
- (2) One-third of the total number of members of the Academic Council will constitute the quorum for the meeting of the Academic Council.
- (3) Each member, including its Chairperson, will have one vote, and decisions at the meetings of the Academic Council will be taken by simple majority; and in case of a tie, the Chairperson will have a casting vote.
- (4) Any business that may be necessary for the Academic Council to perform, which may be urgent in nature, will be carried out by circulation amongst its members.

18. Finance Committee

- (1) The composition of the Finance Committee will be—
 - i. Vice-Chancellor - Chairperson;
 - ii. Pro Vice-Chancellor (wherever applicable);
 - iii. one person nominated by the society or trust or company, as the case may be (wherever applicable);
 - iv. three persons to be nominated by the Executive Council, out of whom at least one will be a member of the Executive Council;
 - v. One representative will be nominated by the Commission;
 - vi. three persons to be nominated by the Chancellor;
 - vii. Finance Officer - Secretary - ex officio.
- (2) All members of the Finance Committee other than ex-officio members will hold office for a term of three years.
- (3) The Finance Committee will meet at least four times in an academic year (at least twice each semester) to examine the accounts and scrutinise the proposals for expenditure, and one-third of the total number of members of the Finance Committee will form the quorum for a meeting.
- (4) All proposals relating to the creation of posts and those items which have not been included in the Budget will be examined by the Finance Committee before the Executive Council considers them, and to decide waivers in fees, the establishment of scholarships, freeships, and any other financial benefits.

- (5) The annual accounts and financial estimates of Malla Reddy (MR) Deemed to be University prepared by the Finance Officer will be laid before the Finance Committee for consideration and comments, and thereafter the same will be submitted to the Executive Council for approval.
- (6) The Finance Committee will recommend limits for the total recurring and non-recurring expenditures for the year, based on the income and resources of Malla Reddy (MR) Deemed to be University.

19. Board of Studies


- (1) There will be one Board of Studies for each department or school of Malla Reddy (MR) Deemed to be University. The composition of the Board of Studies will be—
 - i. Dean of the school or Head of the department - Chairperson;
 - ii. All Professors of the school or department;
 - iii. Two Associate Professors of the school or department, by rotation;
 - iv. Two Assistant Professors of the school or department, by rotation; and
 - v. Two external experts to be co-opted for their specialised knowledge.
- (2) Subject to the overall control and supervision of the Academic Council, the functions of a Board of Studies will be to approve subjects for research for various degrees and other requirements of research degrees and to recommend to the concerned School Board in such manner as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University regarding—
 - i. Courses of studies;
 - ii. Appointment of supervisors for research; and
 - iii. Measures for the improvement of the standards of teaching and research.
- (3) The powers and functions of the Board of Studies will be prescribed by the rules of Malla Reddy (MR) Deemed to be University.

20. Selection Committee for appointment of teaching staff

There will be one or more Selection Committees constituted for making recommendations to the Executive Council for appointment to the post of Professors, Associate Professors, Assistant Professors, and such other posts as may be prescribed, in accordance with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.

21. Disqualification

- (1) A person will be disqualified for being chosen as, and for being, a member of any of the authorities, or being appointed as, and for being, an officer of Malla Reddy (MR) Deemed to be University if—
 - i. he or she is of unsound mind; or
 - ii. he or she is an undischarged insolvent; or
 - iii. he or she has been convicted by a court of law for an offense involving moral turpitude and sentenced in respect thereof to imprisonment for not less than six months; or
 - iv. he or she has not been appointed as per the provisions of these regulations.

- (2) If any question arises as to whether a person is or had been subjected to any of the disqualifications mentioned above, the question will be referred to the Chancellor, and his or her decision will be final, and no suit or other proceedings will lie in any civil court against such decision.

22. Miscellaneous matters relating to different authorities

- (1) If any question arises as to whether any person, other than Government nominated or appointed, has been duly nominated or appointed as, or is, entitled to be a member of any authority or any committee of Malla Reddy (MR) Deemed to be University, the matter will be referred to the Chancellor, whose decision thereon will be final and binding.
- (2) Any member, other than an ex-officio member of any authority, may resign by a letter addressed to the Registrar, and the resignation will take effect as soon as it is accepted by the Chancellor or the Chairperson of the Executive Council, as the case may be.
- (3) Sudden vacancies among the members of any authority or any Committee of Malla Reddy (MR) Deemed to be University will be filled by the respective authority, as soon as may be, and within a period of six months.


23. Officers of Malla Reddy (MR) Deemed to be University

A. Chancellor:

- (1) The Chancellor will hold office for a period of five years from the date of assuming office and will be eligible for re-appointment for one more term by following the procedure prescribed for the appointment of the Chancellor:
PROVIDED that the Chancellor in Malla Reddy (MR) Deemed to be University will be appointed by the sponsoring body.
- (2) The Chancellor will, by virtue of his or her office, be the head of Malla Reddy (MR) Deemed to be University and will, if present, preside at the Convocations of Malla Reddy (MR) Deemed to be University held for conferring degrees.
- (3) Where power is conferred upon the Chancellor to nominate persons to authorities, he/she shall, to the extent necessary, nominate persons to represent the various interests for the furtherance of the objectives of the Institutions Deemed to be University.

B. Vice-Chancellor:

- (1) The Vice-Chancellor will be a whole-time salaried officer of Malla Reddy (MR) Deemed to be University and will be appointed by the Chancellor from a panel of three names suggested by a Search-cum-Selection Committee.
- (2) The qualifications of the Vice-Chancellor will be in accordance with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.

- (3) The procedure for composition of Search-cum-Selection-Committee (SCSC) for the selection of Vice-Chancellor will be as under—
- a nominee of the Chancellor, who will be a reputed academician as the Chairperson of the Committee;
 - a nominee of the Chairman, University Grants Commission; and
 - an academician, with not less than ten years' service as Professor, nominated by the Executive Council.
- (4) The Vice-Chancellor will hold office for a term of five years from the date on which he or she enters upon his or her office or until he or she attains the age of seventy years, whichever is earlier, and will be eligible for re-appointment for one more term by following the procedure prescribed for the appointment of Vice-Chancellor:

Provided that notwithstanding the expiry of the said period of five years, he or she will continue in office until his or her successor is appointed and enters upon his or her office; however, in no case, the Vice-Chancellor will hold office beyond the age of seventy years:

Provided further that the Chancellor may direct the Vice-Chancellor, after his or her term has expired, to continue in office for such period, not exceeding a total period of one year.


- (5) If the office of the Vice-Chancellor becomes vacant due to death, resignation or otherwise, or if he or she is unable to perform his or her duties due to ill health or any other cause, the Pro-Vice-Chancellor will perform the duties of the Vice-Chancellor:

Provided that if the Pro-Vice-Chancellor is unavailable, the Chancellor will appoint the senior most Professor who will perform the duties of the Vice-Chancellor until a new Vice-Chancellor assumes office or the existing Vice-Chancellor resumes the duties of his or her office, as the case may be.

C. Powers and duties of Vice-Chancellor:

- (1) The Vice-Chancellor will be the Principal Executive Officer and academic officer of Malla Reddy (MR) Deemed to be University and will exercise general supervision and control over the affairs of Malla Reddy (MR) Deemed to be University and give effect to the decision of all authorities of Malla Reddy (MR) Deemed to be University.
- (2) The Vice-Chancellor may, if he or she is of the opinion that immediate action is necessary on any matter, exercise any power conferred on any authority of Malla Reddy (MR) Deemed to be University by or under these regulations and will report to such authority at its next meeting the action taken by him or her on such matter:

PROVIDED that, if the authority mentioned in this sub-regulation is of the opinion that such action ought not to have been taken, it may refer the matter to the Chancellor whose decision thereon will be final:

PROVIDED further that any person in the service of Malla Reddy (MR) Deemed to be University who is aggrieved by the action taken by the Vice-Chancellor under this regulation will have the right to represent against such action to the Executive Council within ninety days from the date on which decision on such action is communicated to him and thereupon the Executive Council may confirm, modify or reverse the action taken by the Vice-Chancellor.

- (3) The Vice-Chancellor, if he or she is of the opinion that any decision of any authority of Malla Reddy (MR) Deemed to be University is beyond the power of the authority conferred by the provisions of these regulations or that any decision taken is not in the interest of Malla Reddy (MR) Deemed to be University, may ask the authority concerned to review its decision within sixty days of such decision and if the authority refuses to review the decision either in whole or in part or no decision is taken by it within the said period of sixty days, the matter will be referred to the Chancellor whose decision thereon will be final.
- (4) The Vice-Chancellor will be the ex-officio Chairperson of the Executive Council, the Academic Council and the Finance Committee and will, in the absence of the Chancellor, preside at the Convocations held for conferring degrees to the students.
- (5) The Vice-Chancellor will be entitled to be present at, and address, any meeting of any authority or other body of Malla Reddy (MR) Deemed to be University, but will not be entitled to vote unless he or she is a member of such authority or body.
- (6) It will be the duty of the Vice-Chancellor to see that these regulations are duly observed and implemented and he or she will have all the powers necessary to ensure such implementation.
- (7) The Vice-Chancellor will have all the powers necessary for the proper maintenance of discipline in Malla Reddy (MR) Deemed to be University, and he or she may delegate any such powers to such person or persons as he or she may deem fit.
- (8) The Vice-Chancellor will have the power to convene or cause to be convened the meetings of the Executive Council, the Academic Council, the Finance Committee, and other authorities.

D. Removal of Vice-Chancellor:

- (1) Where there are reasons to believe that the Vice-Chancellor of Malla Reddy (MR) Deemed to be University does not possess the qualifications as required under the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, or is not appointed as per the procedure stipulated in these regulations or has committed any financial or administrative impropriety, the Chairman of the Commission will constitute an enquiry committee consisting of academic, administrative or financial experts to inquire into the matter.
- (2) On the directions from the Commission, the Chancellor will place the Vice-Chancellor under suspension, pending an enquiry.
- (3) The enquiry committee will give an opportunity of hearing to the Vice-Chancellor before submitting its report to the Commission and where the report of the enquiry committee confirms the ineligibility or procedural violations or impropriety, as the case may be, the Commission will direct the Chancellor to remove the Vice-Chancellor by following due procedure.

- (4) Notwithstanding anything contained in these regulations, the Chancellor may, at any time after the Vice-Chancellor has entered upon his or her office, by order in writing, remove the Vice-Chancellor from office on the grounds of incapacity, misconduct or violation of these regulations:

PROVIDED that the Chancellor will make no such order unless the Vice-Chancellor has been given a reasonable opportunity of showing cause against the action proposed to be taken against him:

PROVIDED further that the Chancellor may, at any time before making such order, place the Vice-Chancellor under suspension, pending an inquiry.

E. Pro-Vice-Chancellor:

- (1) On the recommendation of the Vice-Chancellor, the Executive Council will appoint a Professor as Pro-Vice-Chancellor to discharge the duties of the Pro-Vice-Chancellor in addition to his or her duties as a Professor:

PROVIDED further that where the recommendation of the Vice-Chancellor is not accepted by the Executive Council, the matter will be referred to the Chancellor, who may either appoint the Professor recommended by the Vice-Chancellor or ask the Vice-Chancellor to recommend the name of another Professor for re-consideration by the Executive Council.


- (2) The term of office of the Pro-Vice-Chancellor will be such as may be decided by the Executive Council, but it will not, in any case, exceed five years or until the expiration of the term of office of the Vice-Chancellor, whichever is earlier:

PROVIDED that the Pro-Vice-Chancellor whose term of office has expired will be eligible for re-appointment by following the procedure prescribed for the appointment of Pro-Vice-Chancellor:

PROVIDED further that the Pro-Vice-Chancellor will, while discharging the duties of the Vice-Chancellor, continue in office, notwithstanding the expiration of his or her term of office as Pro-Vice-Chancellor, until the Vice-Chancellor resumes office or a new Vice-Chancellor assumes office, as the case may be:

PROVIDED also that, in any case, the Pro-Vice-Chancellor will retire on attaining the age of sixty-five years.**

- (3) The Pro-Vice-Chancellor will have the powers and duties as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University.
- (4) The Pro-Vice-Chancellor will assist the Vice-Chancellor in respect of such matters as may be specified by the Vice-Chancellor on this behalf, from time to time, and will also exercise such powers and perform such duties as may be assigned or delegated to him by the Vice-Chancellor.

F. Registrar:


- (1) (a) The Registrar will be a whole-time salaried officer of Malla Reddy (MR) Deemed to be University and will be appointed by the Executive Council on the recommendations of the selection committee consisting of the following:—
 - i. Vice-Chancellor - Chairperson;
 - ii. one nominee of the Chancellor;
 - iii. two members of the Executive Council nominated by it; and
 - iv. one expert not in the service of Malla Reddy (MR) Deemed to be University to be nominated by the Executive Council.
- (b) The meeting of the selection committee will be fixed after prior consultation with, and subject to the convenience of the Chancellor's nominee and the experts nominated by the Executive Council, and the proceedings of the selection committee will not be valid unless at least three of the Chancellor's nominees or persons nominated by the Executive Council attended the meeting.
- (2) The Registrar will hold office for a term of five years from the date of assuming office and will be eligible for re-appointment for a second term by following the procedure prescribed for Registrar:

PROVIDED that, the Registrar will retire on attaining the age of sixty-two years and the emoluments and other terms and conditions of service of the Registrar will be such as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University.

- (3) When the office of the Registrar is vacant or when the Registrar is, by reason of illness, absence, or any other cause, unable to perform the duties of his or her office, the duties of the office will be performed by such person as the Vice-Chancellor may appoint for the purpose.
- (4) The Registrar will be ex-officio Secretary of the Executive Council and the Academic Council, but will not be deemed to be a member of any of these authorities.
- (5) The Registrar will be directly responsible to the Vice-Chancellor and will work under his or her direction.
- (6) The Registrar will have the power to take disciplinary action against employees, excluding teachers and other academic staff, as may be specified in the order of the Executive Council and to suspend them pending inquiry, to administer warnings to them or to impose on them the penalty of censure or the withholding of increment:

PROVIDED that no such penalty will be imposed unless the person has been given a reasonable opportunity of showing cause against the action proposed to be taken in regard to him or her.

- (7) An appeal will lie to the Vice-Chancellor against any order of the Registrar imposing any of the penalties specified in sub-regulation (6).
- (8) In the case where the inquiry discloses that a punishment beyond the power of the Registrar is called for, the Registrar will, upon the conclusion of the inquiry, make a report to the Vice-Chancellor along with his or her recommendations:

PROVIDED that an appeal will lie to the Executive Council against an order of the Vice-Chancellor imposing any penalty.

(9) It will be the duty of the Registrar—

- a. To be the custodian of the records, the common seal, and such other property of Malla Reddy (MR) Deemed to be University as the Executive Council will commit to his or her charge;
- b. To issue all notices convening meetings of the Executive Council, the Academic Council, and any Committees appointed by those authorities;
- c. To keep the minutes of all the meetings of the Executive Council, the Academic Council, and any Committees appointed by those authorities;
- d. To conduct the official correspondence between the Executive Council and the Academic Council;
- e. To supply to the Chancellor copies of the agenda of the meetings of the authorities of Malla Reddy (MR) Deemed to be University as soon as they are issued and the minutes of such meetings;
- f. To represent Malla Reddy (MR) Deemed to be University in suits or proceedings by or against the University, sign powers of attorney and verify pleadings or depute his or her representative for the purpose;
- g. To perform such other duties as may be specified in the rules of Malla Reddy (MR) Deemed to be University or as may be required from time to time by the Executive Council or the Vice-Chancellor as the case may be;
- h. To enter into an agreement, sign documents, and authenticate records on behalf of Malla Reddy (MR) Deemed to be University;
- i. To make arrangements to safeguard and maintain the buildings, gardens, office, canteen, cars and other vehicles, laboratories, libraries, reading rooms, equipment and other properties of Malla Reddy (MR) Deemed to be University; and
- j. To conduct the official correspondence on behalf of the authorities of Malla Reddy (MR) Deemed to be University.

G. Finance Officer:

- (1) The Finance Officer will be appointed by the Executive Council on the recommendations of a selection committee constituted for the purpose and he or she will be a whole-time salaried officer of Malla Reddy (MR) Deemed to be University.
- (2) The Finance Officer will be appointed for a term of five years and will be eligible for re-appointment by following the procedure prescribed for the appointment of the Finance Officer:
Provided that, the Finance Officer will retire on attaining the age of sixty-two years.
- (3) The emoluments and other terms and conditions of service of the Finance Officer will be such as may be prescribed by the Executive Council from time to time.
- (4) When the office of the Finance Officer is vacant or when the Finance Officer is, by reason of illness, absence or any other cause, unable to perform the duties of his or her office, the duties of the office will be performed by such person as the Vice-Chancellor may appoint for the purpose.

- (5) The Finance Officer will be ex-officio Secretary of the Finance Committee but will not be deemed to be a member of such Committee.
- (6) The Finance Officer will—
- exercise general supervision over the funds of Malla Reddy (MR) Deemed to be University and will advise it as regards its financial policy; and
 - perform such other financial functions as may be assigned to him by the Executive Council or as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University.
- (7) Subject to the control of the Executive Council, the Finance Officer will—
- ensure that the limits fixed by the Executive Council for recurring and non-recurring expenditures for a year are not exceeded and that all amounts of money are expended for the purpose for which they are granted or allotted;
 - be responsible for the preparation of annual accounts and the budget of Malla Reddy (MR) Deemed to be University and for their presentation to the Executive Council;
 - keep a constant watch on the state of the cash and bank balances and on the state of investments;
 - watch the progress of the collection of revenue and advise on the methods of collection employed;
 - ensure that the registers of buildings, land, furniture, and equipment are maintained and up-to-date and that stock-checking is conducted of equipment and other consumable materials in all offices, departments, schools, faculties, centers and specialized laboratories;
 - bring to the notice of the Vice-Chancellor unauthorized expenditure and other financial irregularities and suggest disciplinary action against persons at fault;
 - call for from any office, department, school, faculty, centre, laboratory, etc. maintained by Malla Reddy (MR) Deemed to be University any information or returns that he or she may consider necessary for the performance of his or her duties; and
 - work under the direction of the Vice-Chancellor and will be responsible to the Executive Council through the Vice-Chancellor.
 - He/she shall be responsible for the management of funds and investments of Institution Deemed to be University, subject to the control of Executive Council or the Vice-Chancellor from time to time.

H. Controller of Examinations

- The Controller of Examinations will be appointed by the Executive Council on the recommendations of a selection committee constituted for the purpose and he or she will be a whole-time salaried officer of Malla Reddy (MR) Deemed to be University.
- The Controller of Examinations will be appointed for a term of five years and will be eligible for reappointment by following the procedure prescribed for the appointment of the Controller of Examination:

Provided that the Controller of Examinations will retire on attaining the age of sixty-two years.

- (3) The emoluments and other terms and conditions of service of the Controller of Examination will be such as may be prescribed by the Executive Council from time to time.
- (4) When the office of the Controller of Examinations is vacant or when the Controller of Examinations is, by reason of illness, absence or any other cause, unable to perform the duties of his or her office, the duties of the office will be performed by such person as the Vice-Chancellor may appoint for the purpose.
- (5) The Controller of Examinations will arrange for and superintend the examinations of Malla Reddy (MR) Deemed to be University in the manner as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University.
- (6) The Controller of Examinations will be a permanent invitee to the Academic Council.
- (7) The Controller of Examinations will ensure that all the specific directions of the Executive Council, Academic Council and Vice-Chancellor in respect of examination and evaluation are complied with.

I. Dean


- (1) The Departments dealing with allied subjects may be grouped into faculties or schools, etc., and every faculty will be headed by a Dean.
- (2) Every Dean of the school or faculty will be appointed by the Vice-Chancellor from amongst the Professors in the school or faculty, by rotation, for a period of two years:

PROVIDED that if there is only one Professor or no Professor in a school or faculty, the Dean will be appointed, for the time being, from amongst the Professor, if any, and the Associate Professors in the school or faculty.

- (3) When the office of the Dean is vacant or when the Dean is, by reason of illness, absence or any other cause, unable to perform the duties of his or her office, the duties of the office will be performed by the senior-most Professor or Associate Professor, as the case may be, in the School.
- (4) The Dean will be the Head of the school or faculty or centre and will be responsible for the conduct and maintenance of the standards of teaching and research in the school or faculty or centre and will have such other functions as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University.
- (5) The Dean will have the right to present and speak at any meeting of the Board of Studies or Committees of the school or faculty or centre, as the case may be, but will not have the right to vote there unless he is a member thereof.

J. Head of the Department

- (1) There will be a Head of the Department or chairperson of the centre for each of the department or centre in Malla Reddy (MR) Deemed to be University, who will be appointed by the Vice-Chancellor from amongst the Professors of the department or centre:

PROVIDED that if there is no Professor in the department or centre or there is only one Professor in the department or centre, whose term as Head of the department or chairperson of the centre is ending, the Vice-Chancellor may appoint an Associate Professor as Head of the Department.

- (2) The term of the Head of the department or chairperson of the centre will normally be two years and he or she will be eligible for re-appointment for one more term by following the procedure prescribed for the appointment of the Head of the department or chairperson of the centre.
- (3) The powers and functions of the Head of the department or chairperson of the centre will be prescribed by the rules of Malla Reddy (MR) Deemed to be University.


24. Admission and fees structure

A. Admission

Admission of students to Malla Reddy (MR) Deemed to be University will be strictly based on merit in the entrance exam conducted by a Government Testing Agency or Malla Reddy (MR) Deemed to be University and as prescribed by the appropriate statutory authority, wherever applicable and in case of no entrance examination, the admission of students to Malla Reddy (MR) Deemed to be University may be made in the manner specified in the prospectus.

B. Fee structure

- (1) Donation or capitation fee in whatever nomenclature or form, either directly or indirectly, is strictly prohibited.
- (2) Malla Reddy (MR) Deemed to be University will follow the rules and regulations regarding fee structure, number of seats, etc., issued by the relevant statutory bodies and in case Malla Reddy (MR) Deemed to be University offers different courses which come under the regulatory ambit of different statutory bodies, namely the University Grants Commission, the All India Council of Technical Education, National Medical Council etc., the rules and regulations regarding fee structure, number of seats, etc., issued by such statutory body concerned will be applicable.
- (3) The fee will be fixed transparently, keeping in view non-profiteering or non-commercial aspects.
- (4) The fee will be collected as declared in the prospectus of Malla Reddy (MR) Deemed to be University and with a proper receipt for such payment and the prospectus will also state that donation or capitation fee in whatever nomenclature or form, either directly or indirectly, will not be collected from the student or parent and in case of any grievance, the student or parent may submit their complaint to Malla Reddy (MR) Deemed to be University.
- (5) Malla Reddy (MR) Deemed to be University may provide fee concession or scholarships or may allocate some seats to meritorious students belonging to socially and economically deprived groups of the society.
- (6) Malla Reddy (MR) Deemed to be University will abide by all the University Grant Commission notifications, guidelines regarding the refund of fees and return of original certificates, as may be issued from time to time.

- (7) Every Malla Reddy (MR) Deemed to be University will maintain the records of the entire process of selection of candidates, exhibit such records on its website, and preserve such records for a minimum period of five years.
- (8) Malla Reddy (MR) Deemed to be University will make available the prospectus on its website at least sixty days before the commencement of admissions, including fee structure, refund policy, number of seats in a programme, eligibility qualifications, admission process, etc.
- (9) Malla Reddy (MR) Deemed to be University will not retain any original certificates of the students, faculty members, and staff.

25. Malla Reddy (MR) Deemed to be University open to all

- (1) Malla Reddy (MR) Deemed to be University will be open to the persons of all genders and of whatever caste, creed, race or class, and it will not be lawful for Malla Reddy (MR) Deemed to be University to adopt or impose on any person any test whatsoever of religious belief or profession in order to entitle him or her to be appointed as a faculty member of Malla Reddy (MR) Deemed to be University or to hold any other office therein or to be admitted as a student in Malla Reddy (MR) Deemed to be University or to graduate thereat or to enjoy or exercise any privilege thereof:

PROVIDED that nothing in this section will be deemed to prevent **Malla Reddy (MR) Deemed to be University** from making special provision for the employment or admission of women, persons with disabilities, or of persons belonging to the weaker sections of society and, in particular, of the Scheduled Castes, the Scheduled Tribes and the other socially and educationally backward classes of citizens.

- (2) All policies and procedures, in matters of admission, fee, and employment as applicable to the university level public funded and self-financing institutions, respectively, will apply.

26. Malla Reddy (MR) Deemed to be University to be unitary —


Malla Reddy (MR) Deemed to be University will be unitary in nature and will not affiliate any other institution.

27. Reservation policy —

Malla Reddy (MR) Deemed to be University will implement the policy on reservations in admissions and recruitment, in accordance with the provisions of the Constitution of India and any Act of Parliament for the time being in force and will disclose all such information on its website.

28. Online or distance education —

Malla Reddy (MR) Deemed to be University may offer courses online or distance courses or degrees in accordance with the regulations notified by the Commission from time to time.

29. Power to conduct enquiry and consequences for violation of regulations —

- (1) Where the Government or the Commission, as the case may be, receives information by way of a complaint or otherwise, that ****Malla Reddy (MR) Deemed to be University**** has violated any of the provisions of these regulations, it will cause to conduct an enquiry into the facts of such information after issuing a notice to the said effect to ****Malla Reddy (MR) Deemed to be University****.
- (2) The Commission may also cause an inspection to be made by experts in matters of academics, administration, and finance regarding academic outcomes or any matter connected with the administration or finances of ****Malla Reddy (MR) Deemed to be University**** for the purpose of the enquiry.
- (3) Based on the enquiry or through procedures mentioned in these regulations, if the Government or the Commission, as the case may be, is satisfied that the regulations have been violated, ****Malla Reddy (MR) Deemed to be University**** will be subjected to such action as provided in the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023.

30. Funds, Accounts, Audit, and Annual Report —

- (1) The books of accounts of Malla Reddy (MR) Deemed to be University will be maintained, managed, and operated in the name of Malla Reddy (MR) Deemed to be University and not in the name of the sponsoring body or any other body; and will be kept in such form as may be specified by the Executive Council and will conform to the rules or regulations, if any, prescribed by the Commission, in this regard.
- (2) Funds will not be diverted at any time from the accounts of Malla Reddy (MR) Deemed to be University to any other accounts, including to the accounts of the sponsoring body or to any other body.
- (3) Malla Reddy (MR) Deemed to be University will get its books of accounts audited annually, separately published, and uploaded on the website of Malla Reddy (MR) Deemed to be University and the accounts of Malla Reddy (MR) Deemed to be University will also, where required, be open for inspection by the Commission.
- (4) The annual financial statements and accounts will be audited by a qualified professional, a Member or Fellow of the Institute of Chartered Accountants of India, to be appointed by Malla Reddy (MR) Deemed to be University;

PROVIDED that the Commission may, on receipt of information regarding financial impropriety or embezzlement or illegal diversion of funds from the accounts of Malla Reddy (MR) Deemed to be University; or of fees being collected against the provisions of these regulations, issue a notice directing Malla Reddy (MR) Deemed to be University to show cause as to why an inspection, including a forensic audit, will not be ordered in respect of the complaint, and after providing a reasonable opportunity to the respondent Malla Reddy (MR) Deemed to be University, the Commission may on being satisfied that there were sufficient grounds to proceed further, cause an inspection by a team of the Commission or may direct a forensic audit; the report of and the inspection team and the forensic audit report taken together will form the basis for the Commission to take further action, as it may be deemed fit, under these regulations including the recommendation for withdrawal of Malla Reddy (MR) Deemed to be University status to the Government.

- (5) Annual Reports, Annual Financial Statements, and Audit Reports will be uploaded on the Malla Reddy (MR) Deemed to be University website and also on the Commission's portal, after due approval by the Executive Council.

31. Miscellaneous

- (1) Malla Reddy (MR) Deemed to be University will, as soon as may be, after the completion of the academic programme, and in no case later than one hundred and eighty days from the date of such completion, ensure that the degree, diploma, certificate, or any other qualification in respect of the programme of studies, is awarded and made available to students.
- (2) Malla Reddy (MR) Deemed to be University will compulsorily create Academic Bank of Credits (ABC), identities of their students and upload their credit scores in digital lockers and ensure that the credit scores are reflected in the ABC portal and adopt Samarth e-Gov.
- (3) Malla Reddy (MR) Deemed to be University will not at any time enter into any franchise agreement or arrangement, either overtly or covertly, with any individual or organisation for establishing, maintaining, or operating the off-campus or off-shore campus or constituent units or course or programme of study or department or school or faculty of Malla Reddy (MR) Deemed to be University except in the following cases, namely:—
 - a) Malla Reddy (MR) Deemed to be University, which is eligible under sub-regulations (1) and (2) of regulation 8 may enter into an agreement or arrangement, if—
 - i. the establishment, maintenance, or operation of such institution is permitted under any Act of Parliament or the rules or regulations made there under; and
 - ii. it has made an application under sub-regulation (3) of regulation 8, after following the procedure specified in these regulations.
 - b) The campus to be established under such agreement or arrangement will be—
 - i. treated as an off-campus centre of Malla Reddy (MR) Deemed to be University as long as such agreement or arrangement remains valid under such law; and
 - ii. subject to similar standards of audit and disclosure as a not-for-profit entity as that of Malla Reddy (MR) Deemed to be University.
 - c) Malla Reddy (MR) Deemed to be University, which is eligible under regulation 8 may enter into an agreement or arrangement for practical training of students of a skill-oriented vocational courses, if such course is approved by the University Grants Commission or any other body established under any Act of Parliament.
 - d) Twinning Programmes, Joint Degree Programmes, and Dual Degree Programmes will be offered in accordance with the provisions stipulated in the University Grants Commission (Academic Collaboration between Indian and Foreign Higher Educational Institutions to offer Twinning, Joint Degree, and Dual Degree Programmes) Regulations, 2022.
 - e) The income and property of Malla Reddy (MR) Deemed to be University will be utilised solely for promoting the objectives of Malla Reddy (MR) Deemed to be University.

- f) The Commission will have the power to issue directions to Malla Reddy (MR) Deemed to be University for implementation of any public policy of the Government or in respect of any law in force, including appropriate directions in case of any violation of any law or policy by Malla Reddy (MR) Deemed to be University.
- g) No portion of the income and property of Malla Reddy (MR) Deemed to be University will be paid or transferred directly or indirectly, by way of dividend, bonus, or otherwise howsoever by way of profit to the persons who were at any time or are members of Malla Reddy (MR) Deemed to be University or to any of them or any persons claiming through them:

PROVIDED that nothing herein contained will prevent the payment in good faith of remuneration to any member thereof or another person as consideration for any service rendered to Malla Reddy (MR) Deemed to be University or for travelling or other allowances and such other charges.

- h) In consultation with the Commission, the Government will have the power to impose such other conditions, not inconsistent with these regulations, in the notification, and the same will be binding on Malla Reddy (MR) Deemed to be University.
- i) Where Malla Reddy (MR) Deemed to be University wishes to surrender its status of Malla Reddy (MR) Deemed to be University, it will do so with the prior permission of the Government; and similarly, withdrawal of any constituent units or off-campus or off-shore campus of Malla Reddy (MR) Deemed to be University from the purview of Malla Reddy (MR) Deemed to be University, will require the sponsoring body to take the prior permission of the Government:

PROVIDED that such surrender or withdrawal, as the case may be, will take effect only after the last batch of students on the rolls of Malla Reddy (MR) Deemed to be University or its constituent units, as the case may be, have been accorded the opportunity to qualify for the completion of the programme of study and award of degree.

- j) Malla Reddy (MR) Deemed to be University will furnish to the Central Government or the Commission such returns or other information with respect to its property or activities as the Central Government or the Commission may, from time to time, require, within such period as may be specified by the Central Government or Commission.
- k) Convocations of Malla Reddy (MR) Deemed to be University for conferring the degrees or for other purposes will be held in such manner as may be prescribed by the rules of Malla Reddy (MR) Deemed to be University.
- l) The Executive Council may, by a resolution passed by a majority of not less than two-thirds of the members present and voting, withdraw a degree of academic distinction conferred on, or any certificate or diploma granted to, any person by Malla Reddy (MR) Deemed to be University for good and sufficient cause:

PROVIDED that no such resolution will be passed until a notice in writing has been given to that person calling upon him or her to show cause within such time as may be specified in the notice as to why such a resolution will not be passed and until his or her objections, if any, and any evidence he or she may produce in support of them, have been considered by the Executive Council.

- m) In the event of conflict of opinion with regard to the interpretation of these regulations, the opinion of the Commission will be final.
- n) The provisions contained in the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023 will prevail in case of any inconsistency or conflicting provisions in any other regulations issued by the Commission under the provisions of the Act.


32. Legal Proceedings —

- (1) The Registrar may sue or be sued for the purpose of any legal proceedings against Malla Reddy (MR) Deemed to be University, who will have the power to enter into agreements, sign documents and authenticate records on behalf of Malla Reddy (MR) Deemed to be University, and will have the powers to exercise such powers and perform such duties under the provisions of these regulations.
- (2) No suit or legal proceedings will lie against the Government or the Commission in respect of anything done or purported or intended to be done in pursuance of any of these regulations.

33. Consequences of the violations of regulations

In the event of non-compliance of any of the provisions as enumerated herein above or any other provisions as stipulated in the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023, Malla Reddy (MR) Deemed to be University will be liable to be subjected to one or more of the following actions, namely:—

- a) For violation of these regulations established by the enquiry committee set up by the Commission or Government, Malla Reddy (MR) Deemed to be University will be warned in writing with public notice or barred from any expansion in terms of diversification to new courses or programmes of study or departments and establishment of off-campus or off-shore campuses for a period of three years or as recommended by the enquiry committee, whichever is higher;
- b) Continuous violation of regulations established by the enquiry committee set up by the Commission or the Government may result in closure of the courses or programmes of study or Departments and off-campus or constituent institutions or off-shore campuses or may result in withdrawal of the status of Malla Reddy (MR) Deemed to be University;
- c) In order to protect the interests of students in case of surrender or withdrawal of the status, as the case may be, will take effect only after the last batch of students on the rolls of Malla Reddy (MR) Deemed to be University or its constituent units has been accorded opportunity to qualify for the completion of the programme of study and award of degree.



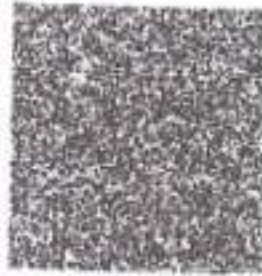
